

Basics & Checking Eligibility

- The Comptroller of Maryland is processing direct stimulus payments to over 420,000 eligible recipients, and an estimated 98% of those payments are expected to be processed by Friday, February 19th. Are you eligible? Check marylandtaxes.gov/RELIEFAct
- The Comptroller's Office is working steadfastly to ensure your RELIEF Act stimulus payment reaches you as quickly as possible. Those receiving their payment through direct deposit should see their accounts reflected by the end of the week, or early the week of February 22nd. Check your eligibility at marylandtaxes.gov/RELIEFAct
- More than half of the eligible recipients of the RELIEF Act stimulus will receive their money via direct deposit. While these are being processed as quickly as possible, be aware that each bank has their own processing time and may take several business days to appear in your account. Are you eligible? Check online at marylandtaxes.gov/RELIEFAct
- More than half of eligible recipients of the RELIEF Act stimulus will receive their money via direct deposit. Are you one of them? Check your eligibility at marylandtaxes.gov/RELIEFAct
- Has your address or banking information changed since filing your 2019 taxes? Email RELIEFAct@marylandtaxes.gov or call 1-833-345-0787 to provide the Comptroller of Maryland with updated information It will help us get your stimulus payment to you faster!
- Are you eligible for the RELIEF Act direct stimulus but want to update your address or bank account information? You can email RELIEFAct@marylandtaxes.gov or call 1-833-345-0787 for all your RELIEF Act payment questions!
- Did you file for the Earned Income Tax Credit in Tax Year 2019? You may be eligible for the RELIEF Act state stimulus check! Confirm your eligibility at marylandtaxes.gov/RELIEFAct

Finding 6,500 Marylanders

- ATTENTION! The Comptroller of Maryland is trying to connect 6,500 Marylanders with their state stimulus, but we need an updated address or bank account. - There are over 6,500 Marylanders whose stimulus payment is on hold because the Comptroller of Maryland needs an updated address or direct deposit information to send the payment! Help us spread the word, check your eligibility at marylandtaxes.gov/RELIEFAct, or update your information by emailing RELIEFAct@marylandtaxes.gov or calling 1-833-345-0787.

- The Comptroller of Maryland has over 6,500 direct stimulus payments that can't be disbursed without updated banking or address information! Share with your friends, family, or neighbors: they can check their eligibility at marylandtaxes.gov/RELIEFAct or update their information by emailing RELIEFAct@marylandtaxes.gov or calling 1-833-345-0787.
- While most of those eligible for the RELIEF Act direct stimulus payment don't need to take any action, more than 6500 Marylanders will have to contact the Comptroller's Office to claim their money. If the agency does not have a valid bank account or USPS-validated mailing address on file, you will need to provide the correct information.
